Designed for grades 1-4 of general secondary education, this assessment system is mainly in the field of reading and mathematics. Students' knowledge is assessed based on the knowledge gained in the textbooks. This rating system is used in more than 70 countries around the world. EGRA is an individually administered verbal assessment aimed at assessing children's literacy skills in the primary grades. It has been adapted by DepEd in accordance with international standards and guidelines.

The EGMA is an individual oral test designed to measure skills in elementary math and elementary grades. It has been adapted by DepEd in accordance with international standards and guidelines. [1]

The Assessor (assessor, supervisor) is a DepEd staff (teacher, school leader or supervisor) trained to administer EGRA or EGMA while adhering to standard procedures for testing management. [2]

In February 2019, a discussion was held on the implementation of this international assessment study in cooperation with the Ministry of public education of Uzbekistan and representatives of the US Agency for International Development (USAID). These studies will help to improve the assimilation of Primary School students and identify the shortcomings in the educational process.[3]

2,8 thousand pupils of the secondary school took part in this international assessment system. EGRA and EGMA studies are planned to be conducted in 7 languages and in English in 12 regions of our country. From these programs, the EGRA program includes several large and small assignments.[4,5] for example, the ability to read on the basis of a text, consisting of about 60 words, is determined by the oral fluency reading instruction. Bunda precision and speed are important. Time is set to 60 seconds. If none of the words on the first line (that is, about 10 words) is not correctly read, it will stop.

DISCUSSION

Another of the assignments in the EGRA international program, is listening comprehension. In this assignment, the text corresponding to the class to the reader is read verbally, and on the basis of the text given in this reading, the reader listens and responds verbally to the test questions through the concept adopted. Below are presented text and test questions, consisting of 80-90 words, designed for students of the 4th grade.
