The sentence reads: "We honored the elders of every nation and every country, we gave them gifts and benefited from their services."

In his works I.A. Karimov spoke about the role and influence of the family on the formation and development of our national spirituality, "The spiritual world of the family", "The family is the fortress of spirituality", "The spiritual environment in the family". We must not forget that spirituality is a unique and powerful factor in the upbringing of the younger generation, because we are warned that "ignoring this issue is very valuable not only for some parents, but also for society as a whole." In his book "High spirituality is an invincible force", President Islam Karimov expresses the following views on the role of the family in human development: "Undoubtedly, the role and influence of the family in the formation and development of the unique spirituality of each nation are incomparable. Because the purest feelings of a person, the first life ideas and ideas are formed primarily in the family. The role of parents in raising mature children in a family is equal and requires high responsibility. In our country, measures to strengthen the family, educate a spiritually mature, physically healthy generation are carried out on the basis of a number of international conventions.

In the upbringing of a harmoniously developed generation, much attention is paid to the centuries-old traditions of national upbringing, the wide and rational use of national and universal values. The Family Code, which is important in the life of our society, also plays an important role in the legal and moral foundations of family relations, the duty of parents to society and the child. Speaking about the family, I.A. Karimov stresses the following: "In a word, it is clear to all of us that the healthier the family, the stronger the society, the more stable the country."

Rather, the family is a hotbed of upbringing, ensuring the continuity of generations, fulfilling the intentions of parents, relatives and society, bringing up a harmoniously developed person who will serve the country, state and society.

Along with children raised in a family, in the hands of parents, there is a young generation in our society who is brought up in orphanages.

Meloderd houses are educational institutions opened by the state for orphans and children left without parental care or other legal representatives.

Children brought up in them are also under the protection of the state, and pupils of schools of the Republic of Uzbekistan, who are brought up in orphanages, are provided by the state with textbooks, textbooks, clothes, food, etc. Together with the orphanage and the school where the children study, a plan for cooperation in educational work has been developed, according to which educators and school teachers regularly conduct educational activities.

To control the regular attendance of pupils, a duty schedule for the teachers of the House of Mercy was developed and implemented. Particular attention is paid to the fact that each teacher conducts additional classes together with school teachers, special attention is paid to increasing the level of knowledge of students, preparing them for blood Olympiads, conducting educational activities together with class teachers. School teachers visit the House of Mercy twice a week to provide additional training for students with learning disabilities and to improve the effectiveness of students' knowledge.

### 3. CONCLUSION

Cooperation is conducted with the mahallas in which the students were born. They visit each new foster child's home, check his / her marital status and draw up a report, and educational work is carried out with children with special needs in cooperation with their parents and the community. In the process of working with citizens' self-government bodies, special attention should be paid to children from disadvantaged families (drug addicted or alcoholic families, low-income families, etc.). If local police officers and school psychologists worked closely with children with difficult upbringing, the number of children with disabilities in orphanages would decrease, or the list of children with difficult upbringing in the neighborhood would decrease.

From this we can conclude that for the stability of society, the upbringing of our youth in a healthy and harmonious way, strengthening the family, the neighborhood, which is a spiritual fortress that ensures the eternity of life, the continuity of generations, should not stop, this is not only our main task, but also our human debt.
